Certificate, License or Ordination Programs

- Forerunner Certificate (\$50 Admin Fee)** - For those desiring deeper truths of God's word. This certificate is given to those who desire to be equipped with God's prophetic truth to be prepared as end-time forerunners.
- Licensing Certificate (\$50 Admin Fee)** - Some have been called to both preach God's word, serve in the marketplace, and/or serve in a Ministry. Those who are licensed have the evidence of this calling and therefore apply to receive ministry licensing.
- Ordination Certificate (\$50 Admin Fee)** - Those who have received the gift to serve God in full time ministry in one of the fivefold offices (Apostle, Prophet, Evangelist, Pastor, Teacher) can apply to become ordained under FMA. An ordained minister under FMA is one who primarily makes his/her living from the ministry he/she serves in.
