Congratulations on your completion of the FMA classes. You are now ready to receive your Ministry License or Ordination. The final step is to complete a background check and pay for the issuing of your valid License or Ordination card.

*\*Your application must be submitted along with the \$125 fee for License or Ordination, as well as, the recommendation letter from your pastor.*

*\*If you are sending check please write two separate checks, \$125 for ordination/license & \$35 for background.*

*\*Your card must be renewed every year for it to stay valid. The cost of renewal is \$125.*

Please select between license or ordination:

- License (\$125)** - Some have been called to both, preach God’s word, serve in the marketplace, and/or serve in a Ministry. Those who are licensed have the evidence of this calling and therefore apply to receive ministry licensing.
- Ordination (\$125)** - Those who have received the gift to serve God in full time ministry in one of the fivefold offices (Apostle, Prophet, Evangelist, Pastor, Teacher) can apply to become ordained under FMA. An ordained minister under FMA is one who primarily makes his/her living from the ministry he/she serves in.
